Thank you for being a loyal member and putting your valuable trust in our Maine Water Environment Association for all these years. Last year we changed our administrative service provider from Maine Municipal Association (MMA) to Maine Water Utilities Association (MWUA). MWUA was able to keep initial costs in line with previous MMA contracts, while providing more member benefits and considerably more dedicated staff time. Some services did cost slightly more, and we anticipate additional increases in service costs going into 2023. The value for these additional services is easy to quantify. Having Joan's full attention to our membership saw one of the most successful Fall Conventions in recent memory. Her presence has also taken a lot of the burden off our all-volunteer Executive Committee. Additionally, we are better supported through our agreement with MWUA with benefits like Member Clicks, a graphic design contractor, and a website contractor.

Moving into 2023, after the sloughing our industry took in the wake of PFAS press and related legislative action, the MeWEA board has executed a contract with a PR firm. Our goal is to rebrand our industry again as community leaders, essential personnel, and stewards of environmental and public health.


Beginning January 1, 2023, we are increasing the pricing of our membership to the following:
