PRESIDENT'S MESSAGE

March 19, 2021

As we move into spring, we are all ramping up for another busy year of construction, disinfection, and for a good portion of the state, tourism. The MEWEA Government Affairs Committee continues to work very hard for our members. The Committee has provided testimony on multiple bills that affect us all. The MEWEA Vice President and Pretreatment Chair continue their work on getting an informational commercial about the problems that non-flushable items cause for sewer systems. Here is a link to a video that was done in New Hampshire: https://youtu.be/6bmcWqTfhVM.

I'm sure everyone has heard that President Biden just signed a new \$1.9 trillion stimulus package. Within that legislation \$350 billion was allocated to water, sewer, and broadband and does not need to be COVID-19 related. We do not yet know what the allocations will be for the State or how it will be distributed once Maine gets its share. MEWEA is in contact with state officials to attain this information as soon as possible. We will keep you posted as we become informed.

You may remember in the One Water Newsletter there was a request from DEP for some information regarding biosolids spreading. I am adding that request from DEP to this message to ensure that everyone received it.

1. Review and compile facility records by year for land application fields and quantity land applied per field. This one can be tricky in that we have found that field names often change in the records, so it would be helpful if alias names are used that they be identified in the compilation.

MEWEA supports this effort and encourages members who have run land application programs to provide the requested information if able.

2. Identify major industrial inputs (if any) of PFAS compounds into the biosolids during the time of land application. For example, textile mills may have used PFAS compounds in their process, and hence should be identified if they contributed wastewater to the treatment plant during the time of land application. This information can assist in determining relative risk of a site or field relative to nearby receptors.

MEWEA supports this effort and encourages members who have run land application programs to provide the requested information if able.

3. Take a first cut at prioritizing fields for follow-up evaluation based on information from items 1 and 2 above with the addition of looking at current nearby receptors, typically being residential wells. For example, a field that was subject to higher land application use than another field and has several nearby residential wells would be considered a higher priority than a low-use field with few nearby residential wells.

MEWEA is not inclined to recommend participation but is passing along the request. Along with items 1 and 2, this could require significant staff resources, especially with regard to identifying receptors. Just as the Department has limited resources to take on these tasks, many of our utility members are equally constrained. Given the complexity of this task, this would put pressure on management to take on additional work, where they may already be overburdened by the daily demands of overseeing facility operations and utility management.

After discussing items 1 through 3 above with the Department, perform soils testing in identified fields in accordance with approved sampling procedures. This request would necessitate discussions to arrive at an agreed upon plan and would be at a level appropriate for screening a site to understand potential source strength.

MEWEA is not inclined to recommend participation but is passing along the request. Again, the concern is resources, both financial and staffing, as well as other issues that are yet to be defined.



It is with great sadness that I must announce the loss of our friend and colleague, Glen Bellefleur. For 31 years, Glen was a dedicated and admired employee of the Scarborough Sanitary District, the past four years as the District's Chief Plant Operator. He was instrumental in the day-to-day operations of the District's wastewater treatment facility, and served as a mentor to many other District professionals. Operators across the state called Glen to get his feedback and help them troubleshoot their operations, since everyone knew his strong skills

and knowledge of the wastewater treatment process. The Maine Department of Environmental Protection and the Maine Water Environment Association both recognized Glen's skills and requested- on several occasions!- his help teaching operators. He participated in the Maine Water Environment Association's Personnel Advancement Committee, helping identify topics that would be helpful and pertinent to wastewater utilities around the state. He was acknowledged by the Joint Environmental Training Coordinating Committee in 2009 with its Founders Award, which is presented to people whose work in a Maine municipal or industrial wastewater treatment system is truly exceptional based on experience, length of service, dedication, performance during significant events, and community involvement.

Glen passed away in Scarborough on May 29th, 2021 at the age of 55. He was born in Hartford, CT to Vernon and Della Bellefleur on October 26th, 1965. PRESIDENT'S MESSAGE JULY 2, 2021

We have reached the halfway point of 2021 and things are starting to get back to normal. I recently had the opportunity to be on a Zoom meeting with NEWEA and all the member associations. In that call I learned of something called a "Water Advocate." It is a simple way to make your voice heard by your representatives in DC. Just follow the above link and, after a few easy steps, you are ready to go.

As with most industries, water, wastewater, and stormwater are experiencing supply shortages. I spoke with Jason Chadwick of E.J. Prescott this morning and he informed me that PVC pipe is taking anywhere from 3 weeks to 6 months depending on size and quantity needed. It has also almost tripled in price over the last year. Castings have gone up roughly 25% over the last year and currently have a lead time of 4-6 weeks. A quick Google search revealed that although raw materials seem to be in good quantity, manufacturing and shipping is still suffering due to a workforce shortage. A couple of utilities in Maine have even reported having vehicle orders cancelled.

Our legislative group has been hard at work following the infrastructure bills. Emily Prescott and Tim Wade worked hard on letters to both Senator King and Senator Collins supporting the bipartisan infrastructure funding. We are truly fortunate here in Maine that both of our Senators were selected to be a part of this bipartisan effort. As information becomes available, we will be sure to help get the word out to our members.

Finally, I just wanted to tell everyone to have a magnificent Independence Day. 245 years and counting since our forefathers signed the Declaration of Independence. Let us not forget that this day is meant to celebrate our freedom!!!

It is with great sadness that we announce the sudden passing of Kenneth Locke, recently retired Director of Environmental Services and past Superintendent of Brewer Water Pollution Control Facility - affectionately also known as "Emmet." Many of us were fortunate to have seen Ken in September at MeWEA's Fall Convention at Sunday River where he received JETCC's Lee Agger Award on September 16th. That was only the latest of many industry awards that Ken and the Brewer treatment plant received during his career.

Ken Locke's 42-year career in Water Pollution Control included the last 29 years serving the City of Brewer in various capacities. In June, Ken retired from his role as Brewer's Director of Environmental Service. Prior to that, Ken served his community as Brewer's Director of Public Works and as Superintendent of Brewer Water Pollution Control Facility. Throughout his career, Ken led efforts to clean-up CSOs and garnered grants and funds to develop a stormwater and sewer separation program. Ken's work has been instrumental in helping to clean-up the Penobscot River which today boasts a waterfront walking path and other attractions. Always an advocate of community and industry education, Ken assisted with many training classes and always encouraged his staff to do the same.

So many in our industry were shocked by the news of Ken's passing as he was also about to begin post-retirement work with Olver Associates where he was to continue assisting with the operation of Maine treatment plants.

Ken's work was always supported by Brewer's Chief Operator Lou Colburn who had just been hunting with him last weekend. Lou referred to Ken as his "sidekick, his mentor, a true environmentalist, and a great boss. Ken was always proactive in everything including his efforts to take the lead on getting his crew and the City of Brewer at the forefront of stormwater management."

During Ken's retirement party earlier this year Bill Olver of Olver Associates stated "Ken is a humble man, and he is always the first to give credit to the professional staff that he has managed and to the support and financial commitment that the Brewer City Council and Administration have made to its environmental programs. He should be remembered for the pivotal role that this career has played in the success of Brewer's programs. He is the dedicated person on the ground that made it all happen."

Noting sentiments from many who also knew Ken, Leeann Hanson of JETCC stated that "Ken was just a really great person. I remember him from my own early days in this industry. He was always friendly, and one of those silent doers who just gets a lot accomplished. It was always nice to see Ken at events and I recall the many conferences he attended with his wife Kim by his side.

Travis Jones had this to say, "Ken was an excellent boss and mentor, who led by example. He was a consummate professional who lived and breathed his commitment to be the best operator he could be. Ken was a man who did, instead of told. The City of Brewer is fortunate beyond calculation to have had Ken at the helm. I think I'll miss his sense of humor the most, and the way he'd boisterously laugh at a good joke or story. I morn his loss for Kim & his family, his many friends, myself, and our entire wastewater community. Let us all strive to emulate his unwavering commitment to Clean Water."
